



# FAQ's

What do I do if my Pet gets lost? Contact the Shelter immediately! Give all pertinent information and send a picture if possible. Post flyers. Have all pets spay/ neutered: This will reduce the desire to roam and help pet over population

What happens to a stray animal when it is brought to the shelter? How long do you hold them? Tennessee law requires be held at least 72 hours to give owners a chance to reclaim them. After that they become the property of UCHS and may be placed up for adoption, transferred to another pet placement shelter/rescue or in some cases euthanized.

I can't keep my Pet. Can you take it? The UCHS is an open admission shelter, which means we never turn any animal away. We d not charge a fee but greatly appreciate any donation you can make to help offset our cost of caring for the pet. While we make every effort to rehome and transfer pets, we cannot guarantee placement.

# Hardships for the Shelter...



## Justice for the Animals.

#### 2015 has been a tough year for the UCHS. The

year began with frigid temperatures and measurable snow and ice requiring some staff to stay overnight at the shelter on several occasions. While March did bring some relief in the weather. on Friday the 13th we were faced with one of the largest animal hoarding cases in Tennessee history. But with your support of supplies, volunteerism, and monetary donations we SURVIVED and so did the dogs! With the springtime comes the busy time of puppy and kitten intakes. Vaccinate, picture take, post the pictures, communicate with adopters/rescues, transport to other shelters! WHEW! Then.... ANOTHER HOARDER CASE! On October the 4<sup>th</sup> we assisted the Union County Sherriff's Dept. in removing 50 animals from a residence in Maynardville. The owner was charged and indicted by a grand jury of 15 counts of cruelty to animals. Unlike the earlier case, this time we had to hold the animals in our care until the case was resolved. Due to the expenses incurred, and the amount of time this case was likely to take, the District Attorneys petitioned the judge to order the owner pay a security bond for \$ 6417 due by November the 24th. She did NOT meet the deadline to pay the bond and therefore forfieited ownership of the animals. We are now in the process of evaluating and adopting / transferring many of the animals.

A LOT of hard work and FINANCES went into the care of these animals and we are grateful that we can now help them get on there way to loving, caring homes. We hope you will remember us in your holiday and year end giving again. We can sure use it.
