Annual Fundraising Dinner

Our annual fundraising dinner was held on April 21, 2018. Our guest speaker was Officer Debra Beeler, Union County's Animal Control Officer (ACO). She shared her experiences and knowledge of being an ACO in Knox and Union Counties. She also shared an update on state animal laws with the audience with a question and answer period following her



presentation. We are so thankful to the Union County Sheriff's Office for providing an Animal Control Officer and for all the hard work, dedication, and professionalism that Officer Beeler has exhibited in this position.

We are also grateful to have dedicated supporters, like you, who make it possible to provide care to nearly 2,000 unwanted and abandoned animals in our extended community. Auctioneer, Martin Shafer, held a fun, lively bidding war of the many wonderful items donated by local businesses and individuals. Annual Yard Sale

Alexis Browning spearheaded this year's yard sale which was held October 5-6, and brought in over \$5,500 for the shelter. The yard sale had a little something for everyone including furniture, tools, household items, toys, books, and children's items! Thank you's to Janet Holloway, everyone who donated items for the yard sale, all who purchased items, and the strong backs of the many volunteers who helped make the event a success.

2018 Animal Hoarding Cases in Union County

The Union County Humane Society assisted the Union County Sheriff's Office in two major hoarding cases in 2018—one involving 52 cats and the other involving 84 dogs. In the cat hoarding case, the owner was charged and pled guilty to animal cruelty. Similarly, in the dog hoarding case, a couple was charged and pled guilty to animal cruelty.



On May 30, 84 Jack Russell Terrier mix dogs were taken from a Union County property. Veterinarians and students from the University of Tennessee School of Veterinary Medicine arrived on June 1 to perform evaluations and administer vaccinations and necessary medication to the dogs. Many area shelters and rescues stepped in to help. After behavioral evaluations, love and attention, some dogs were adopted

directly or transferred to shelters in the north for adoption. On November 10, the remaining two dogs from this case were transferred to an ASPCA rehabilitation facility.

Doggie PlayPen

Through the help of volunteers Pat Hurley, Evan Bailey, and Devon Helton as well as gravel donations from Loyston Road Quarry, a 35' x 60' fenced-in doggie playpen was completed in early April. This area has allowed for off-leash activity to



further assess doggie behavior, to allow for more intensive exercise, to provide dog-to-dog active play, and to provide for a larger adopter meet-and-greet area. A great addition to our Dog Enrichment program.

Free Cat Spay and \$5 Cat Neuter Specials

Through the generosity of our supporters, we offered free cat spays to the first 100 appointments during a 6-week period between February and April 2018. This effort saw an immediate benefit in limiting unwanted litters in our community. Dr. Hutchison also helped us offer a \$5 cat neuter special on October 29 to help nearly 30 boys get cuter. While we all think kittens are adorable, it breaks our hearts when there are not enough adopters to support the supply of unwanted litters. Thank you to all who participated in spaying and neutering your cats!

NO APPOINTMENT is necessary to surrender your pet or stray during normal business hours (10am – 4pm Monday through Saturday).


NO FEE to surrender an animal; although donations are greatly appreciated to help support our continued services.

Minnie Pearl Survives Fan Belt Injury and Finds a New Home



After normal business hours on March 20 while we were having a Union County Humane Society board meeting, the intake doorbell rang. Many of us know that it is either an injured animal coming to us because the lights were on or someone is lost on the country road. Tonight, it was a mother and daughter holding a stray, injured, emaciated, long-haired tabby cat wrapped in a towel. Intake was completed and the

kitty was placed comfortably in the exam room. Tammy and Doc went back to examine the kitty who was extending her paw through the crate as if to say "Howdy!" — so she was named "Minnie Pearl." Doc assessed the injury, determined that it most likely occurred from a vehicle fan belt, and recommended surgery to remove her badly injured rear leg and fix her abdominal injury. Minnie Pearl had a successful surgery and recovery, never loosing her friendly disposition. Some of us even wanted her to be a lobby cat! She found her forever home a couple months after surgery, and has become a very contented indoor-only girl!
